Requirements:

Your annotated bibliography will be a typed document with 5 sources (10 points each). You will include an MLA citation and an annotation for each source.

Your annotation should include a complete C.R.R.A.A.P test for each source as well as a brief summary of the information you will utilize from the source in your speech. Your final product should be spell checked and formatted correctly.
